- vii) Propagating a strike/ disruption of classes.
- viii) Association with banned organizations.
- ix) Propagating communal / caste feeling amongst the students.
- x) Indulging in physical violence in any manner.
- xi) Disobeying lawful orders of the teacher/Vice-Principal/Principal
- xii) Bringing unauthorized people/articles inside the school.
- xiii) Theft/pilferage of school / students property.
- xiv) Any behavior unbecoming of a student.
- xv) Indulging in acts of moral turpitude.
- 2) In above act of misconduct, Principal shall take suitable action as per observation of the Disciplinary committee depending on the gravity of the misconduct, which may include
 - i) Oral and written warning to the student and parents.
 - ii) Suspension from attending classes/ school for a specified period.
 - iii) Recovery of loss to school property
 - iv) Issue of Transfer Certificate
 - v) Expulsion/ rustication from school.
